## About Our Organization...

**CAFSA Constitution BY-LAWS OF  
CHINESE AMERICAN FACULTY AND STAFF ASSOCIATION  
SAN FRANCISCO STATE UNIVERSITY  
(CAFSA - SFSU)**

### ARTICLE I NAME AND PURPOSES

I.1 This organization shall be called Chinese American Faculty and Staff Association, San Francisco State University, which may be abbreviated as CAFSA - SFSU.

I.2 The purposes of this organization shall be:

1. to promote cross-cultural understanding between Chinese Americans and the larger community at San Francisco State University;
2. to open communication with members in the organization on a regular basis and in matters of mutual concern;
3. to support and assist members when feasible;
4. to maintain liaison with similar organizations on campus, in the San Francisco Bay Area and in the United States.

### ARTICLE II ORGANIZATION

The activities of this organization shall be conducted by the Executive Committee to be composed of the following officers:

One President

Two Vice Presidents – one representing the faculty and one representing the administrators and staff

One Secretary

One Treasurer

The above officers shall be elected each year at the first general meeting for a term of office of one year.

### ARTICLE III MEMBERSHIP

Any member of the SFSU faculty, administrators and staff, current or past, active or retired, regardless of sex and racial origin, may apply for membership at the recommendation of two members in good standing, subject to approval by the Executive Committee. Membership dues shall be determined by the organization at its annual general meeting.

### ARTICLE IV AMENDMENT

The by-laws may be amended by a majority of all members in good standing.
